Pursuant to Article 1, paragraph 2 of the Law on Transmission of Electric Power, Regulator and System Operator of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", 07/02, 13/03, 76/09 and 1/11), Article 2, paragraph 1, Article 7, points 7 and 33, paragraph 1, point j) of the Law on Establishing an Independent System Operator for the Transmission System in Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina" 35/04), Article 38 of the Law on Electricity of Republika Srpska ("Official Gazette of RS", 68/2020), Article 41 of the Law on Electricity in the FBiH ("Official Gazette of FBiH", 66/13, 94/15, 54/19 and 1/22), Article 19 of the Law on Electricity ("Official Gazette of BD BiH", 27/21), Articles 8, 12, 13, 17, 19, 20-25 of the Market Rules, point 3.7 of the Licence Conditions for Independent System Operator activities no 05-28-12-17-20/19, and the Rules of Third Party Access to the Transmission System no 04-28-359/06 of 7 December 2006 and in relation to State Electricity Regulatory Commission's document no 04-28-7-343-7/21 of 7 March 2022, Minutes of the Meeting held on 15 March 2022 on access to BiH electricity market to power plants connected to the distribution grid and Minutes of the Meeting held on 5 April 2022 on access to BiH electricity market to power plants connected to the distribution grid and the Working Group's Proposal of the model for implementation of the solution enabling free access to the market for electricity producers connected to the distribution grid, the Working group members appointed by the Decision no 373-3/22 of 11 April 2022, General Director issues the following

DECISION

on the temporary model enabling non-discriminatory and free access to the unique electricity market in BiH for power plants connected to the distribution grid

Article 1

1. This Decision defines transitional and temporary model which enables non-discriminatory and free access to the unique electricity market in BiH for power plants connected to the distribution grid.
2. By this Decision and until adoption of rules and regulations which will permanently regulate access to the electricity market in BiH, electricity producers connected to the distribution grid shall access the electricity market in BiH through Balance Responsible Parties which they can choose freely and which are composed of electricity producers connected to the distribution grid.
3. For the needs of the implementation of the model from paragraph 1 of this Decision, the term to be used for power plants connected to the distribution grid which are part of the Balance Group i.e. of the Balance Responsible Party is "Virtual Power Plant".

4. The term "Virtual Power Plant" defines a group of small power plants connected to the distribution grid which are part of one Balance Group with total (aggregate) installed capacity of at least 1 MW.

Article 2

1. This Decision defines amendments to Instructions for daily schedules delivery with the purpose of enabling the implementation of the model from Article 1, paragraph 1 of this Decision. Instructions for daily schedules delivery shall be published on NOSBiH website upon the adoption of this Decision.
2. This Decision defines the Instruction for the implementation of the temporary model for "Virtual Power Plants" access to BiH electricity market (hereinafter the Instruction) which shall define liabilities and the order of operations of market participants with the purpose of the implementation of the model from Article 1, paragraph 1 of this Decision. The Instruction shall be an integral part of this Decision.

Article 3

This Decision shall come into force on the day of the adoption.
